No operations were carried out this month, efforts are being made to get better results next month.

Legal

- LAGA Legal Department carried out **10 missions** out of Yaounde Centre Region: 1 in Akonolinga (Centre), 2 in Doumé (East), 1 in Abong-Mbang (East), 1 in Bertoua (East), 2 in Ebolowa (South), 1 in Kye-Ossi (South), 1 in Ambam (South) and 1 in Douala (Littoral).
- There are **11 traffickers behind bars this month:** 2 in Centre, 3 in Littoral region and 6 in West region.
- 15 cases were followed up by the Legal Department this month.
- 13 cases were scheduled in court this month.
- **No traffickers** were convicted this month.
- **Prosecutions**: There were no court ruling this month.
