<u>Highlights</u>

- 3 traffickers arrested with 2 elephant tusks in Yaounde, Centre Region. A retired Colonel of the Ministry Forestry and Wildlife that has also been in charge of National Parks was among them.
- The Heads of the Investigation and Legal Departments held a meeting with the Customs Chief of the South West Region to strengthen collaboration in fighting wildlife crime

<u>General</u>

This month was marked by the arrest of 4 traffickers with 2 elephant tusks.

3 traffickers arrested with 2 elephant tusks in Yaounde, Centre Region. A retired Colonel of the Ministry Forestry and Wildlife that has also been in charge of several National Parks was among them. The Colonel has been charged and the case is presently with an examining judge. The traffickers concealed the elephant tusks in the boot of a car. They refused to open the boot in an attempt to foil the arrest operation

The Heads of the Investigation and Legal Departments held a meeting with the Customs Chief of the South West Region to strengthen collaboration in fighting wildlife crime in the region that borders Nigeria and is a hotspot for smuggling of wildlife contraband.

The Legal Team held meetings with several State Counsels to discuss ongoing cases in their respective jurisdictions.

Investigations

- **19 investigation missions** were carried out in **6 regions** out of 10 of Cameroon including the Centre, East, Littoral, Adamawa, North and South.
- Good investigation in Yaounde led to the arrest of 4 ivories traffickers with 2 elephant tusks weighing 15 kg each in Yaounde.

Operation

An operation carried out this month with MINFOF arresting 4 traffickers.

21/8/2024 – 3 traffickers arrested in Yaounde Centre Region with 2 elephant tusks. A retired Colonel of the Ministry Forestry and Wildlife that has also been in charge of several National Parks was among them. The Colonel has been charged and the case is presently with an examining judge. The traffickers concealed the elephant tusks in the boot of a car. They refused to open the boot in an attempt to foil the arrest operation. Two of the traffickers are computer engineers. The traffickers are prosecuted under the new wildlife law that that was recently signed by the President of the Republic.

- LAGA Legal Department carried out **8 missions** out of Yaounde Centre Region: 1 in Ebolowa (South), 1 in Ambam (South), 1 in Sangmelima (South), 1 in Djoum (South), 2 in Ntui (Centre), 1 in Akonolinga (Centre) and 1 in Douala (Littoral).
- There are **14 traffickers behind bars this month:** 5 in Centre, 3 in Littoral region and 6 in West region.
- 20 cases were followed up by the Legal Department this month.
- **11 cases** were scheduled in court this month.
- No traffickers were convicted this month.
- **Prosecutions**: There were no court ruling this month.

- The Head of the Legal Department and two legal advisers held a meeting with the State Counsel of Yaounde Centre Administratif to discuss post operations legal strategies.
- A legal adviser had a meeting with the State Counsel of Ambam to discuss the legal strategies concerning an ivory seizure made by customs in Ambam.
- He held a meeting with the Chief of the Brigade at the South Delegation of Forestry and Wildlife to discuss the legal strategies on the Ambam customs seizures.
- Another legal adviser held a meeting with the State Counsel of Akonolinga to discuss the legal strategies concerning matters pending before their courts.
- A legal had a meeting with the State Counsel of Ntui to discuss the legal strategies on matters pending before the court.
